RLE TASKS

There are a lot of definitions of the family. Burgess in 1963 stated that a family is "A number of persons joined together by bonds of marriage, blood, and adoption". Another good definition comes from Friedman in 1992 stating that a family are "Two or more persons who are joined together by bonds of sharing and emotional closeness and who identify themselves as being part of the family." But how do we really define a family? If we subscribe to the definition of Burgess, which is most likely in the Philippines, one would therefore take care of the traditional family composed of the mother and father (who are wed), their off springs (biological or adopted) and the extended family members. On the other hand, Friedman's definition will, on the other hand, consider more contemporary, alternative relationships in society as a family. These include a group of friends who live under one roof, cohabiting couples (who are not wed) and the like.
